**Training Camps/Trials** – to be determined for each respective camp based on attendance & location.

All athletes competing/attending in either a training camp or competition where Cheema's head coach is or will be representing on behalf of a Cheema athlete the athletes will be expected to contribute fees towards the head coaches cost of attendance. These costs will be determined on an event by event basis and presented to all athletes involved two weeks prior to the event start date.

**Boat storage** - Commencing September 1, 2015, an annual fee of \$75 per year, or any part thereof, applies to all members storing personal boats. This fee is already included in annual membership fees paid by Advanced Program athletes for the storage of one boat, the annual fee will apply to any additional boats stored at Cheema. Please refer to Cheema's Boat Storage Policy. **Notice: If a boat remains at Cheema once membership is no longer active, and after the expiry of the storage year paid, an additional boat storage fee of \$30/month (or any part thereof) will apply until the boat is removed.**

**WAIVER OF LIABILITY**

1. To become a member of Cheema Aquatic Club, the participant(s), his/her parents(s) and/or legal guardians(s) (collectively the "Applicants") all of whom are signed below, agree that Cheema Aquatic Club and all of the directors, officers, employees and representatives shall have no legal liability whatsoever for any injuries or losses sustained by the Applicants resulting from attending the programs and events sponsored by Cheema and the use of equipment and facilities of Cheema Aquatic Club.
2. The Applicants agree to indemnify and hold harmless Cheema Aquatic Club and its respective directors, officers, employees and representatives against all liabilities whatsoever resulting from any injuries or losses as referred to in paragraph 1.
3. The Applicants agree that this Waiver shall bind any servant, agent, invitee, guest, spectator, or any other person associated with the Applicants.

The Applicants acknowledge that all the activities to be carried out by Cheema Aquatic Club have an inherent risk of personal injury, property damage and loss or theft of personal property and the Applicants acknowledge and confirm they are well aware of and understand these risks and that the participant(s) is/are taking part in the activities at Cheema Aquatic Club voluntarily. The Applicants warrant that the participant is in good health and is able to freely participate in the activities carried out by Cheema Aquatic Club and health restrictions, if any, have been noted on the Registration Form.
5. The Applicants agree to be bound by all the rules and regulations as may be published from time to time, which govern activities and the use of the facilities of Cheema Aquatic Club.

**MEMBERSHIP FEE & REFUND POLICY**

6. Per Membership Rate Policy, Cheema Advance Program paddlers shall pay the full yearly rate by the program start date, October 1st. Members in good standing are offered the option of paying with post-dated cheques dated the 1<sup>st</sup> of each month provided all post-dated cheques are received prior to October 1<sup>st</sup>. There are no refunds for months that the paddler does not participate without sufficient written notice provided. Members providing notice of termination in writing to the Coach or Registrar, are eligible for a refund of dues for the months remaining in the training year, less the month following the month in which notice is provided. No refunds are available for notices received eight months after program start date, i.e. May 31<sup>st</sup>.
